Regarding proxies and power of attorney

- A member who cannot personally attend the general meeting may exercise their voting right through a proxy. The proxy must present a written, dated original power of attorney. The power of attorney does not need to be witnessed.
- A member may be represented by a proxy who can be another member of the association, spouse, cohabitant, or a relative permanently residing with the member (§ 21 para. 2).
- A member may also bring an assistant who can be another member of the association, spouse, cohabitant, or a relative permanently residing with the member (§ 21 para. 4).
- Each member has one vote at the general meeting. If multiple members jointly own a housing right, they have only one vote. (The accompanying assistant has no right to speak or vote).
- The power of attorney is submitted by the grantor at the general meeting or submitted in advance to the Board.
