### About representative and power of attorney

- Members who cannot attend the general meeting in person can exercise their right to vote by proxy. The representative must present a written, dated power of attorney in the original. The power of attorney does not need to be witnessed
- A member may be represented by an agent who can be: another member of the association, spouse, common-law partner or close relative who permanently lives with the member (§ 21 sub.2).
- A member may also bring an assistant who can be: another member of the association, spouse, common-law partner or close relative who permanently lives with the member (§ 21 par. 4).
- At the general meeting, each member has one vote. If several members hold a condominium jointly, however, they only have one vote. (Accompanied assistant does not have the right to speak or vote)
- The power of attorney is given by the person giving the power of attorney at the general meeting or given in advance to the board.
